
Description

The Salt US Treasury Dynamic Duration Index provides exposure to the iShares 1-3 Year Treasury Bond ETF (SHY), the iShares 7-10 Year Treasury Bond ETF (IEF) and/or non-remunerated cash. The Index allocates to medium-term Treasuries (IEF) by tracking the percentage change in the 10-Year US Treasury note yield over the last two years. The Index uses an algorithm to determine whether the current 2-year percentage change is above its 100-day moving average by a threshold expected to avoid higher interest rates (and lower bond prices), combining a longer-term and shorter-term momentum signal.

The Index allocates to short-term Treasuries (SHY) by tracking the percentage change in the 2-Year US Treasury note yield over the last year. The Index uses an algorithm to determine whether the current 1-year percentage change is below its 100-day moving average by a threshold expected to lead to lower interest rates (and higher bond prices).

The Index is designed to be a component of a multi-asset index featuring equities, seeking to mitigate the impact of rising interest rates on the portfolio.
