Description

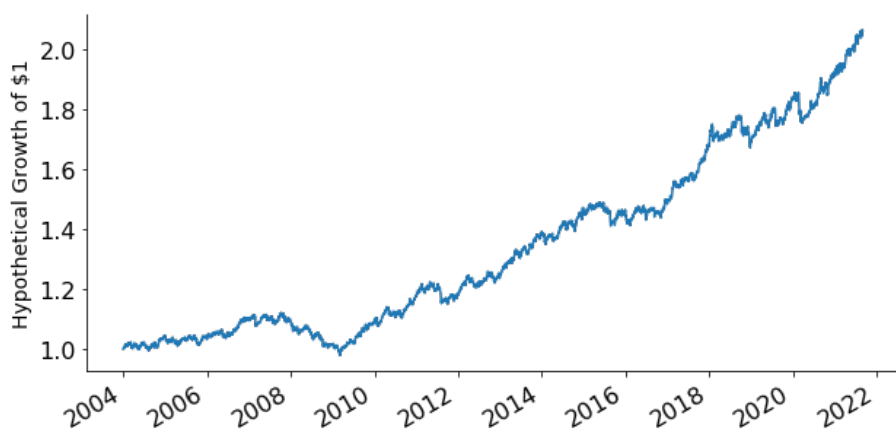
The Salt truVol[®] US Large Cap 5 Index (ticker: SFSP5) is designed to deliver exposure to the SPDR S&P 500 ETF (SPY) while targeting a constant 5% level of volatility. The Index uses the truVol[®] Risk Control Engine (RCE) to dynamically allocate between SPY and non-remunerated cash in aiming to achieve the volatility target. The mechanism generally allocates more to SPY when volatility falls and more to cash when it rises.

The Index is rebalanced daily and calculated in excess of a daily accrual of the Federal Funds Effective Rate (Excess Return).

Index Highlights

- Delivers exposure to the SPY while attempting to maintain a constant volatility level of 5%.
- Targets volatility by adjusting exposure between SPY and cash on a daily basis.
- Uses the truVol[®] Risk Control Engine (RCE), a next generation volatility control mechanism designed to respond more rapidly to changing market conditions.
